# **Policy Statement**

This policy applies where the company (Biomedical Research Models Inc. d/b/a Biomere) receives personal data. Biomere takes the security and privacy of clients/visitors ("you") very seriously. In the event of any conflict between any Service Agreements and this policy, this Privacy Policy shall have precedence.

## **Policy Content**

Under the General Data Protection Regulation (GDPR) and other state specific and other privacy initiatives, personal information may be deemed Personal Data.

#### Introduction

Biomere respects your concerns about privacy. This Privacy Policy explains Biomere's policies and procedures regarding information we collect from or about our clients/visitors and their use of our products and services. Biomere intends to provide you with a level of confidence in how we collect, use, share, and protect information that we collect. This Privacy Policy also explains how you can contact us if you have any questions or concerns. By providing information to us or by using our products or services, you agree to the terms and conditions of this Privacy Policy.

#### Information We May Collect

#### Information Collected for Tracking and Customization (Cookies)

#### **Ensuring the Security of Client/Visitor Information**

#### Data Storage

Biomere uses third party suppliers and hosting partners to provide the necessary hardware, software, networking, storage, and related technology required to run the business.
